Executive Summary

An ordinance authorizing the City Manager to sign the Epidemiology and Laboratory Capacity (ELC) Enhancing Detection (ED) Expansion Amendment 04 Program Services Contract between the City of Columbia and the Missouri Department of Health and Senior Services for the period of July 1, 2021 through July 31, 2025 in an amount not to exceed \$1,452,371.00.

Discussion

The Epidemiology and Laboratory Capacity (ELC) Enhancing Detection (ED) Expansion Program Services Contract was initially executed in December 2021 and allowed for the provision of activities related to the COVID-19 response. Activities include case investigation, contact tracing, surveillance, testing, health education, and professional development. Amendment 04 extends the end of the contract from July 31, 2024 to July 31, 2025 with no change to the funding. Public Health and Human Services will use the remaining funds towards the renovation of its office space. Missouri Department of Health and Senior Services has approved the planned renovation as an allowable use of these funds. This extension of funds was included in the FY25 budget.
