production of a Ninth Street Summerfest event on April 18, 2020, April 19, 2020, and May 1,

2020.

## **Executive Summary**

Staff has prepared for Council consideration of a resolution granting a waiver from the requirements of section 16-185 of the City Code to allow possession and consumption of alcoholic beverages for the Ninth Street Summerfest events on April 18, 2020, April 19, 2020 and May 1, 2020.

#### Discussion

Mike Nolan, manager of The Blue Note, has requested closure of Ninth Street from Broadway to Walnut to hold a 9<sup>th</sup> Street Summerfest on the following dates and times:

- Country music star, Kip Moore on Saturday, April 18, 2020. The closure is requested from 7:00am on Saturday, April 18, 2020 until 1:00am on Sunday, April 19, 2020.
- Rock band "In This Moment" on Sunday, April 19, 2020. The closure is requested from 1:00am until 11:00pm on Sunday, April 19, 2020.
- Country music star, Cody Jinks, on Friday, May 1, 2020. The closure is requested from 7:00am on Friday, May 1, 2020 until 1:00am on Saturday, May 2, 2020.

Mr. Nolan has also requested a waiver from the requirements of section 16-185 of the City Code to allow possession and consumption of alcoholic beverages on Ninth Street for the following dates and times with the estimated attendance to be 3,000.

- Kip Moore: Saturday, April 18, 2020 from 6:00pm until 11:00pm.
- In This Moment: Sunday, April 19, 2020 from 4:00pm until 9:30pm.
- Cody Jinks: Friday, May 1, 2020 from 6:00pm until 11:00pm.

The City Event Committee has approved the application for these events pending Council approval. Conditions of approval have included use of barricades that are compliant with the Manual on Uniform Traffic Control Devices (MUTCD) to block the street and alleyways and procurement of required liquor licensing and liquor liability insurance.

Per City Ordinance 24-73b, an operations agreement is only required for a downtown street closure if the event is to take place the day before, or the day of, any scheduled University of Missouri home football game. The aforementioned requested events are not on University of Missouri home football game weekends.
