Re: Authorizing construction of the Hirth Avenue Storm Water Improvement project and

calling for bids through the Purchasing Division.

### **Executive Summary**

Staff has prepared for Council consideration an ordinance authorizing construction of the Hirth Avenue Storm Water Improvement project and calling for bids through the Purchasing Division. The public hearing for this project was held on June 4, 2018, and the Interested Parties (IP) meeting was held on April 4, 2018.

#### Discussion

The properties at 207 and 209 Hirth Avenue, Exhibit A, currently experience localized flooding during large rain events resulting in storm water next to the house foundations and storm water entering the crawl space of the structures.

The Hirth Avenue Storm Water Improvement Project will consist of constructing approximately 120 linear feet of storm water pipe and two side opening inlets that will connect to the existing 48" RCP pipe located along the south property line of 207 Hirth Avenue, Exhibit B.

Property owners have donated the necessary easements. Construction plans are being finalized, and construction is expected to begin in the fall of 2018. The project will be constructed utilizing existing term and supply contracts or a bid through the Purchasing Division. The current total cost estimate for the project is \$50,000 which includes design, easement acquisition, and construction. The project will be paid for from Storm Water Utility funds.

## Fiscal Impact

Short-Term Impact: The total project cost is estimated at \$50,000 and will be paid from the Storm Water Utility funds.

Long-Term Impact: It is anticipated that this project will have minimal impact to the Storm Water Utility's annual operating cost.
