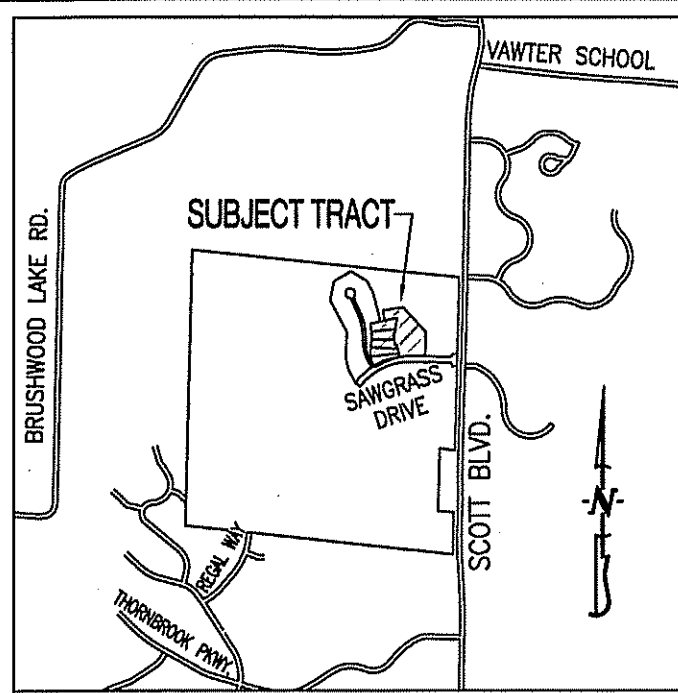


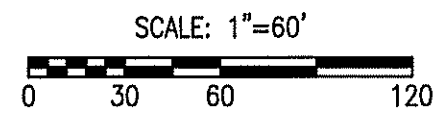
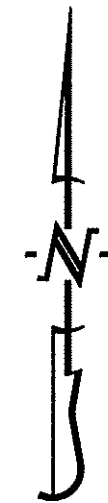

NOT TO SCALE

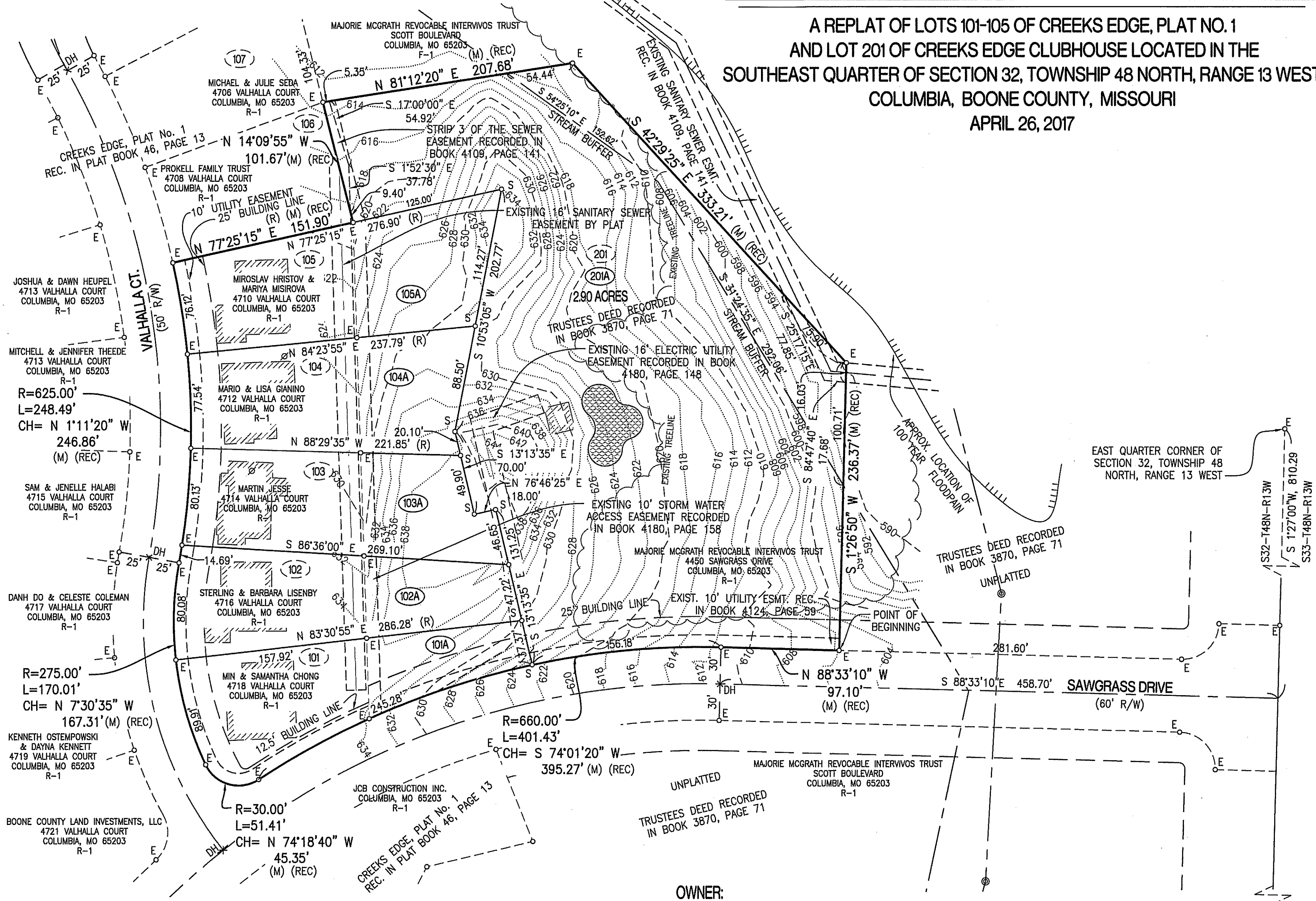

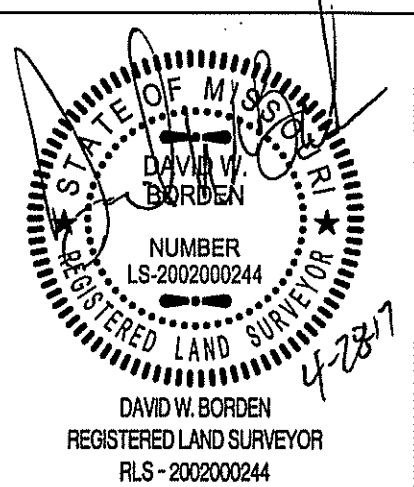
