Re: Authorize a supplemental agreement to the airport aid agreement with the Missouri Highways and Transportation Commission (MHTC) for reconstruction of Taxiway A, Taxiway A1 and Taxiway A2 and portions of Runway 2-20 at Columbia Regional Airport; and amending the FY2021 annual budget by appropriating funds.

Executive Summary

Staff is requesting Council authorize the City Manager to execute a supplemental agreement to the airport aid agreement with MHTC for the reconstruction of Taxiway connectors A, A1, A2, and portions of Runway 2-20. The supplemental agreement allows for additional funding from MHTC and extends the project period to December 31, 2021.

Discussion

On September 17, 2018, Council Bill 227-18 was passed authorizing an airport aid agreement with MHTC to provide fifty percent (50%), or \$229,863, of the City's local ten percent (10%) match required by the Federal Aviation Administration (FAA) for the Runway 2-20 isolated repairs project. The construction project is now complete; however, due to an FAA approved change order to the project, MHTC has agreed to provide additional funding in the amount of \$7,373, which is equal to fifty percent (50%) of the additional match required by the FAA. The supplemental agreement also extends the project time period from October 1, 2020 to December 31, 2021.

Staff is requesting Council authorize the City Manager to execute the supplemental agreement with MHTC, and appropriate \$7,373 from the state revenues account to the Taxiway A, Taxiway A1 and Taxiway A2 and portions of Runway 2-20 project account.
