Proposed Duties and Responsibilities as proposed by AAB:

Periodic review of airport matters as requested by the Board including, but not limited to, financial performance, budgets, capital projects, customer experience, passenger demand analysis, marketing, and master planning, as well as the opportunity to provide input on these matters before requests are submitted to Council.

Prior to approval by AAB, these changes were reviewed with Mayor Buffaloe, City Manager Seewood and Mike Parks, Airport Manager.
