**AN ORDINANCE**

vacating a utility easement within part of Lot 2 of Shultz Subdivision and within parts of Lots 2, 3, 40 and 41 of Atkin's Subdivision located south of Business Loop 70 West, between Madison Street and Jefferson Street (400 Business Loop 70 West); directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that a certain utility easement within part of Lot 2 of Shultz Subdivision and within parts of Lots 2, 3, 40 and 41 of Atkin's Subdivision located south of Business Loop 70 West, between Madison Street and Jefferson Street (400 Business Loop 70 West), more particularly described as follows:

A STRIP OF LAND LOCATED IN THE NORTHEAST QUARTER OF SECTION 11, TOWNSHIP 48 NORTH, RANGE 13 WEST, COLUMBIA, BOONE COUNTY, MISSOURI AND BEING PART OF LOT 2 OF SHULTZ SUBDIVISION RECORDED IN PLAT BOOK 24, PAGE 68, AND PART OF LOTS 2, 3, 40, & 41 AS SHOWN BY ATKIN'S SUBDIVISION, RECORDED IN PLAT BOOK 4, PAGE 13, AND PART OF THE LAND DESCRIBED BY THE WARRANTY DEED RECORDED IN BOOK 3948, PAGE 18, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

ALL THAT PART OF THE 15 FOOT UTILITY EASMENT ON LOTS 2, 3, 40 & 41, AS SHOWN BY ATKIN'S SUBDIVISION, RECORDED IN BOOK 4, PAGE 13 AND SHULTZ SUBDIVISION RECORDED IN PLAT BOOK 24, PAGE 68.

is in excess and surplus to the needs of the City and is hereby vacated.

SECTION 2. The City Clerk is hereby authorized and directed to cause a copy of this ordinance to be recorded in the office of the Recorder of Deeds of Boone County, Missouri.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
