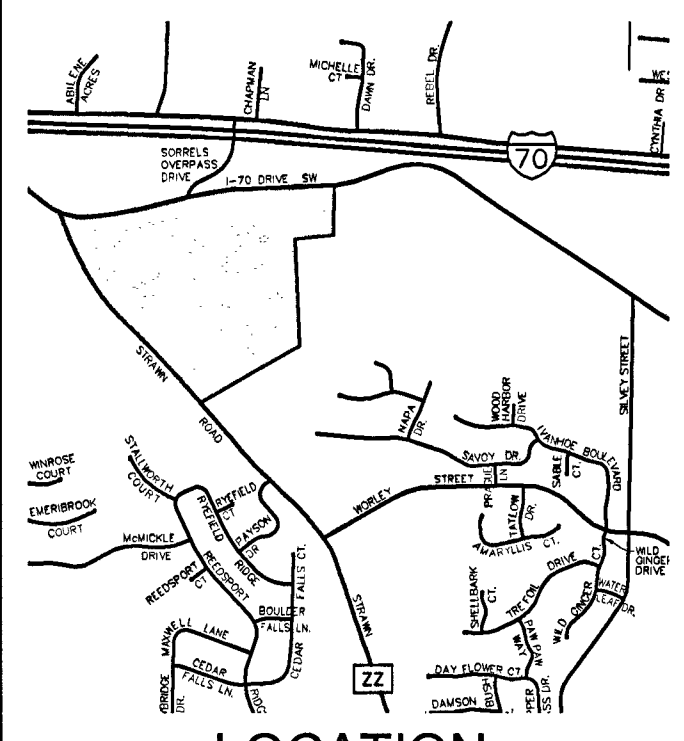
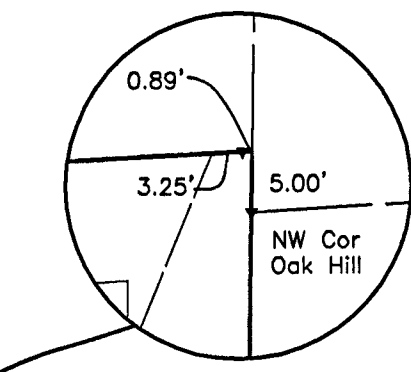

NOTES:

- 1) The east line of the survey recorded in Book 1096 at Page 183 did not conform to the previous survey recorded in Book 957 at Page 789. The monuments that were found appear to match the survey in Book 957 at Page 789. The surveys recorded in Book 3126 at Page 96 and Book 3263 at Page 179 substantially conform to the survey recorded in Book 957 at Page 789, so I based the east line on that survey.
- 2) There were no monuments found along the southwesterly line of the survey recorded in Book 1096 at Page 183 so I used the survey recorded in Book 2587 at Page 22 and the description recorded in Road Book 4 at Page 221 to determine this line.
- 3) I ignored the Right-of-Way monuments that were found along the north line of the Plat, near Station 512+00, because the other monuments that were found seemed to conform to the Stationing found on the Oak Hill Plat recorded in Plat Book 15 at Page 88 and the offsets found in Road Book 1 at Page 82. Unlike most Road Book descriptions there was no description of the centerline.
- 4) I did not set the southeast corner because it is in the creek bed.

DESCRIPTION:
A tract of land located in the Northeast Quarter (1/4) of Section 8, Township 48 North, Range 13 West, in the City of Columbia, Boone County, Missouri, said tract being described by a part of the Trustees Deed in Book 4735 at Page 116, and being shown by the survey as recorded in Book 1096 at Page 183, both of the Boone County Records, and being further described as follows:

BEGINNING at the northeast corner of said survey, said corner being on the east line of said Section approximately S.0°48'45"W, 421.0 feet from the northeast corner of said Section (the section corner was not located as it appears to be in the middle of Interstate 70), and N.0°48'45"E, 5.00 feet from the northwest corner of Oak Hill as recorded in Plat Book 15 at Page 88 of said Records; thence along the east line of said survey and the west line of said Oak Hill S.0°48'45"W, 385.41 feet to the northeast corner of the survey as recorded in Book 957 at Page 789 of said Records; thence leaving said line of said Oak Hill and along the lines of said survey the following five (5) calls: N.51°19'50"W, 300.06 feet; S.67°59'10"W, 222.90 feet; S.11°54'00"E, 817.00 feet; S.1°30'15"W, 224.49 feet; S.59°33'15"W, 429.45 feet to the east corner of the survey as recorded in Book 347 at Page 321 of said Records; thence along the lines of said survey as recorded in said Book 347 at Page 321 and the lines of the survey as recorded in said Book 1096 at Page 183 the following two (2) calls: N.57°42'45"W, 267.34 feet; S.61°07'30"W, 334.99 feet to the northeasterly Right-of-Way line of Strawn Road; thence along said line and the lines of said survey as recorded in Book 1096 at Page 183 the following six (6) calls: N.39°32'50"W, 76.92 feet; along a curve to the left having a radius of 1,944.43 feet a distance of 203.06 feet (the chord of said curve having bearing and distance of N.42°32'20"W, 202.96 feet); N.45°31'50"W, 936.00 feet; along a curve to the right having a radius of 347.05 feet a distance of 201.30 feet (the chord of said curve having bearing and distance of N.28°54'50"W, 198.49 feet); N.12°17'50"W, 114.30 feet; along a curve to the right having a radius of 537.86 feet a distance of 123.07 feet (the chord of said curve having bearing and distance of N.5°44'30"W, 122.80 feet); thence leaving said Right-of-Way line and continuing along the line of said survey as recorded in Book 1096 at Page 183 N.70°00'25"E, 108.12 feet to the south Right-of-Way line of I-70 Drive Southwest; thence continuing along the lines of said survey and said Right-of-Way line the following eight (8) calls: S.77°39'50"E, 21.86 feet; along a non-tangent curve to the left having a radius of 985.30 feet a distance of 474.27 feet (the chord of said curve having bearing and distance of N.88°50'45"E, 469.71 feet); N.75°02'10"E, 609.23 feet; along a curve to the right having a radius of 1,368.50 feet a distance of 287.50 feet (the chord of said curve having bearing and distance of N.81°03'20"E, 286.98 feet); S.2°35'30"E, 14.84 feet; N.87°03'15"E, 199.88 feet; N.1°42'10"W, 5.05 feet; N.87°03'05"E, 496.00 feet to the POINT OF BEGINNING and containing 46.86 acres.

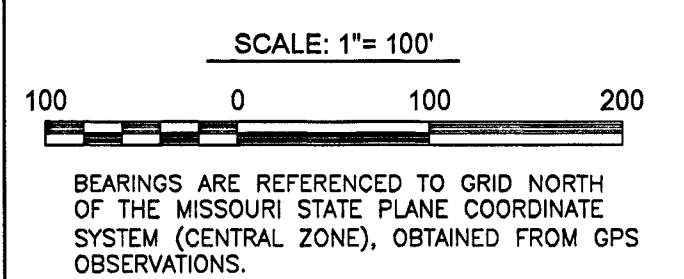
