III. APPROVAL OF AGENDA

VI. NEW BUSINESS

Zach Franklin, CVB Sports Sales Supervisor, presented information on the American Junior Golf Association (AJGA) Missouri Open. The AJGA has presented a Sports Development application to the Columbia Sports Commission for their 2021 event to be held July 25-29. The commission has approved recommending \$15,000 in funding.

The AJGA Stan Utley and Mid-America Youth Golf Foundation Junior Championship is a five-day golf tournament that attracts the most elite players throughout the world, ages 12-19. The 2021 event will host approximately 78 who have gone though a competitive process to qualify. Funds raised from the tournament also go to a Columbia charity organization.

A motion was passed to approve the recommendation of the sports commission to fund this event at the requested amount of \$15,000.

Motion by Marcks. Second by Cristal. Motion carried unanimously.

Kelsey Hammond from the Columbia Art League (CAL), presented a Tourism Development Signature Series application requesting \$20,000 for the 2021 Art in the Park.

This is the 63rd year for the arts festival which will be held June 5-6 in Stephens Lake Park. Because of Covid-19 health restrictions it is unknown at this time the total capacity that will be allowed in the park for this event. There are currently 72 artists who have registered for a booth. Kelsey said they should have definite information on whether it is financially feasible to hold the event by the end of April.

The board voted to support the festival despite the smaller footprint. A motion was made to recommend \$10,000 in funding for marketing and entertainment, with the caveat that funds not be paid out until after April when it determined if the event will be held.

Motion by Jarvis. Second by Cristal. Motion carried.
