**AN ORDINANCE**

determining it is in the public interest to construct sanitary sewers to serve the Henderson Branch Watershed; approving and adopting plans and specifications; determining that the work shall be done by contract; calling for bids through the Purchasing Division; providing for payment for the improvement; authorizing the City Manager to obtain, execute and record all documents necessary for the improvement; providing for compliance with the prevailing wage law and state-mandated construction safety training; and fixing the time when this ordinance shall become effective.

WHEREAS, interested parties meetings for the proposed construction of sanitary sewers to serve the Henderson Branch Watershed were held by the City Utilities Department – Sewer/Stormwater Division on July 5, 2016, October 3, 2016, November 7, 2016 and May 15, 2017; and

WHEREAS, the City Council adopted resolutions, on June 6, 2016 and April 17, 2017 respectively, declaring the necessity for the proposed construction of the improvement project; and

WHEREAS, the resolutions were published in a daily newspaper of general circulation in the city; and

WHEREAS, the City Council has held public hearings on construction of the proposed improvement on July 5, 2016, October 3, 2016, November 7, 2016 and May 15, 2017.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The Council finds that the construction of approximately 8,600 linear feet of 24-inch to 30-inch diameter gravity sanitary sewer to serve the Henderson Branch Watershed in the City of Columbia, Missouri, is necessary for the welfare and improvement of the city and that it is in the public interest that such improvements be made.

SECTION 2. The plans and specifications for this improvement project are hereby approved.

SECTION 3. The construction of the improvement project shall be done by contract in accordance with the plans and specifications, the laws of the State of Missouri, and the Charter and Ordinances of the City of Columbia, Missouri.

SECTION 4. The Purchasing Agent is hereby authorized to call for bids and execute a contract for the improvement project.

SECTION 5. Payment for this improvement project shall be made from funding received from the Boone County Regional Sewer District (\$628,047.00), sewer system revenue bonds (\$2,600,000.00), sewer utility enterprise revenue funds (\$1,071,953.00) and such other funds as may be lawfully appropriated.

SECTION 6. The City Manager is authorized to obtain, execute and have recorded all licenses, easements, deeds and any other conveyances or instruments necessary for the City to complete this improvement.

SECTION 7. Pursuant to Section 290.250 RSMo., the contract for the improvement shall provide that not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under the contract. The contractor's bond shall guarantee the faithful performance of the prevailing hourly wage clause in the contract.

SECTION 8. Pursuant to Section 292.675 RSMo., the bid specifications and contract for the improvement shall provide that the contractor and any subcontractor shall provide a ten-hour Occupational Safety and Health Administration construction safety program (or a similar program approved by the Missouri Department of Labor and Industrial Relations) for all employees working on-site. All employees working on the site of the improvement are required to complete the safety program within 60 days of beginning work on the improvement project.

SECTION 9. This ordinance shall be in full force and effect from and after its passage.
