# Executive Summary

Staff has prepared for Council consideration an ordinance authorizing construction and issuing a contract for the work or a bid call through the Purchasing division for the FY2019 Sanitary Sewer Rehabilitation Project.

The project will consist of rehabilitation of approximately 85,000 linear feet of sewer main, which have been identified by Sewer Utility staff during routine operations and maintenance activities. The public hearing was held on July 1, 2019. The resolution estimate for this project is \$3,200,000 and will be paid from Sewer Utility funds.

### Discussion

The scope of this proposed sanitary sewer system improvement project consists of rehabilitating sewer pipe, sewer structures, and lateral connections to the main located in various areas throughout Columbia. Approximately 85,000 linear feet of sewer main will be rehabilitated due to structural deficiencies and to reduce inflow and infiltration (I&I) in to the sewer system.

Sewer Utility staff has developed specifications and prepared a Request for Proposals (RFP) for the Sewer and Storm Water Rehabilitation and Cleaning Services (multi-year) term and supply contract. Staff anticipates utilizing this term and supply contract for the FY2019 Sanitary Sewer Rehabilitation Project and future sewer and storm water rehabilitation projects. This ordinance authorizes construction either through the City's term and supply contract or by bidding through Purchasing, whichever is most appropriate.

Sewer Utility Staff held an interested parties (IP) meeting on May 7, 2019. A public hearing was held on July 1, 2019. The resolution estimate for this project is \$3,200,000 and will be paid from Sewer Utility funds. The bid call for this project was delayed until the previous sewer rehabilitation project was completed. Upon approval by City Council, the project is anticipated to begin in the winter of 2020 and continue into 2021.

# Fiscal Impact

Short-Term Impact: The total project cost, including construction, is estimated at \$3,200,000 and will be paid from Sewer Utility funds.

Long-Term Impact: Staff anticipates this project will not impact the Sewer Utility's annual maintenance and operation costs.
