Re: Appropriating Funds for Construction of the Forum Boulevard and Green Meadows Road Intersection Improvement Project

Executive Summary

Staff is requesting to appropriate \$662,432 from the 0.25% capital improvement sales tax relating to the construction of the Forum Boulevard and Green Meadows Road Intersection Improvement project. The total estimated cost for this project is \$1,166,500.

Discussion

On June 18, 2018, Council authorized a bid call through the Purchasing Division for construction of the Forum Boulevard and Green Meadows Road intersection improvement project, which consists of a 150-foot diameter partial double-lane roundabout that is situated generally within the existing intersection. This roundabout design includes splitter islands, sidewalks, street lighting, and landscaping. Bids have been received and construction is planned for this summer.

Interested Parties (IP) meetings were held on April 28, 2016 and June 27, 2017. Public hearings were held on September 6, 2016 and September 5, 2017.

The total estimated project cost is \$1,166,500, and is being funded from County Road Tax Rebate funds, which were previously appropriated to the project, and the 0.25% Capital Improvement Sales Tax, which are being appropriated with this ordinance.

Fiscal Impact

Short-Term Impact: Staff is requesting to appropriate \$662,432 from 0.25% Capital Improvement Sales Tax to the Forum Boulevard and Green Meadows Road intersection improvement project. County Road Tax Rebate funds have already been appropriated. Long-Term Impact: Routine maintenance is estimated at \$2,000 per year.
