Executive Summary

This report is provided in response to the Council's request for information regarding single/young parent programs (Project Number 4113). The City of Columbia provides and purchases a variety of health, human, and housing services which support young parents, as described below.

Discussion

The programming currently being purchased specifically for young families is the Resource Parents program provided by Lutheran Family and Children's Services. This program provides intensive case management and home visitation services to pregnant/parenting teens. This programming is intentionally purchased to compliment the City's own Healthy Families America home visitation program which also provides case management, home visitation, developmental screenings, and parent education to high-risk, young families.

The goals of both programs include positive birth outcomes, infant well-being, child abuse/neglect prevention, kindergarten readiness, and economic opportunity for families. In addition, the City purchases a number of health, human, and housing services, from community-based providers, which are available to young parents in low-income households:

With a goal of ensuring all students graduate from high school ready for college or career, the City of Columbia was a founding partner in the Cradle to Career Alliance (C2CA). The C2CA is a group of influential institutions and businesses organized around a common goal of collectively reducing the achievement gap, by improving the performance of all students in our public schools, through the alignment of policies and services built on what works (evidence).

Teen pregnancy is also highly correlated with poor economic outcomes for families. Therefore, the Department of Public Health and Human Services provides services intended to prevent teen pregnancy including family planning services and the Teen Outreach Program (TOP).

Affordable housing is a significant and growing challenge in our community. Increasing the amount of affordable housing for low and moderate income families is a priority in the City of Columbia Consolidated Plan. We also lack emergency shelter and transitional housing for pregnant teens.

It is important to note that with the passage of the Boone County Children's Services Tax, the County of Boone now has significant resources to address issues related to children and youth ages 19 and younger, and their families, including youth homelessness. The Heart of Missouri United Way also purchases a significant number of safety net and income in the community. The City of Columbia, Boone County, and the United Way work very closely together to coordinate the provision and purchase of health, human, and housing services.
