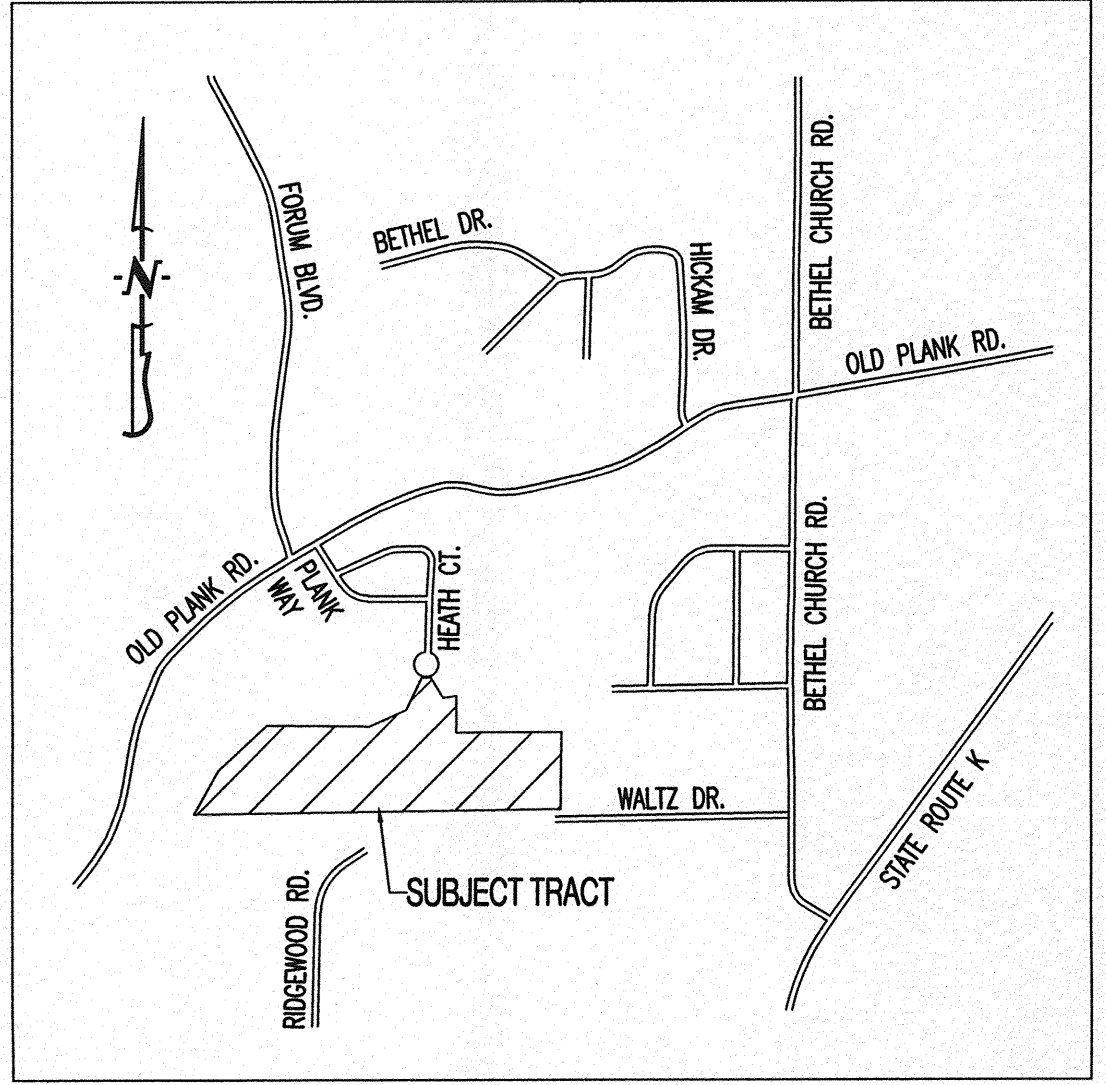


CREEK RIDGE, PRELIMINARY PLAT #2

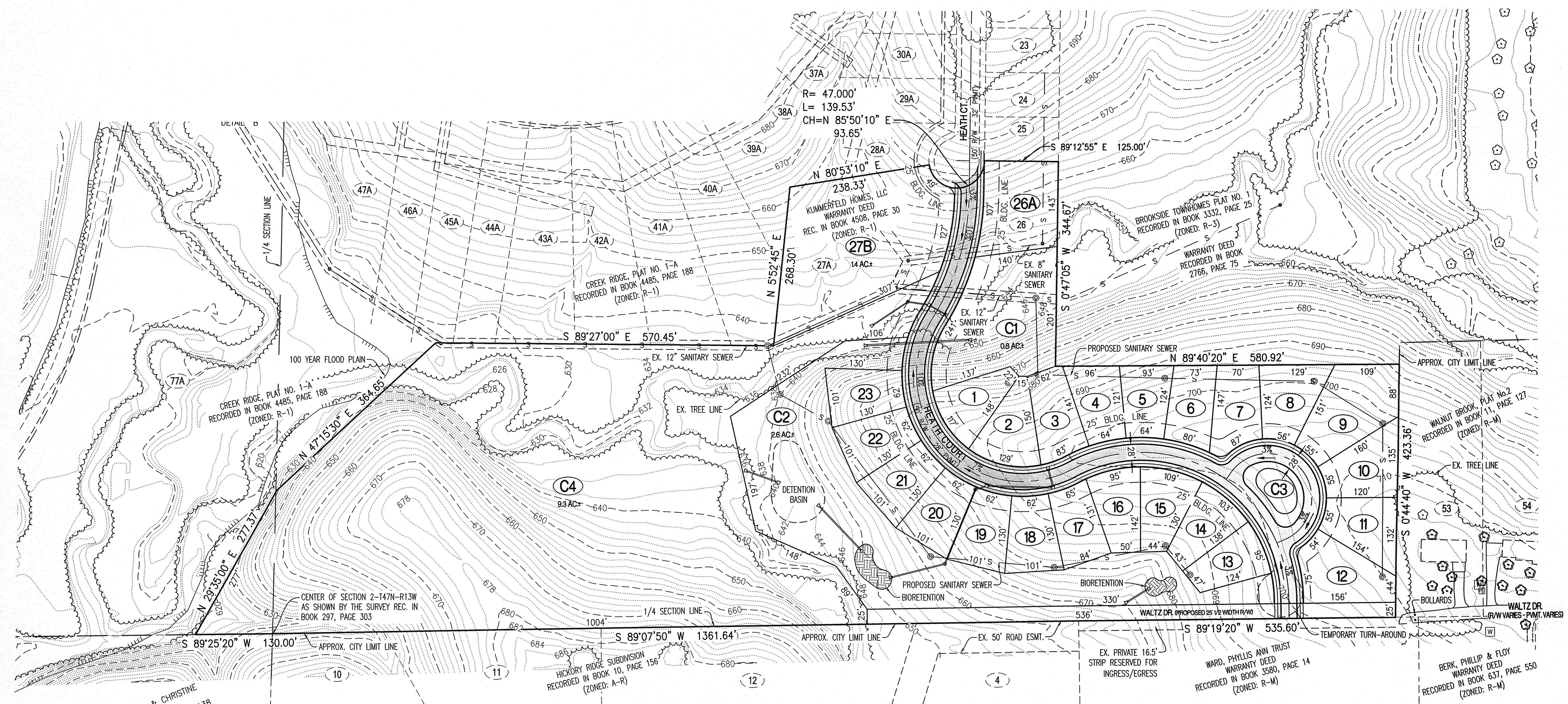
A TRACT LOCATED IN SECTION 2, TOWNSHIP 47 NORTH, RANGE 13 WEST,

- NOTES:**
- ALL PUBLIC SANITARY SEWER EXTENSIONS SHALL BE MINIMUM OF 8" DIAMETER. SEWERS NOT CONSTRUCTED ALONG FRONTS OF LOTS TO BE LOCATED WITHIN 16 FOOT WIDE EASEMENTS OR EASEMENTS EQUAL TO THE DEPTH OF THE SEWER IF SEWER IS GREATER THAN 16 FEET. NO SEWER TAPS WILL BE GREATER THAN 20 FEET.
 - NO PART OF THIS TRACT LIES WITHIN THE 100 YEAR FLOODPLAIN AS ADOPTED BY THE CITY OF COLUMBIA AS SHOWN BY FIRM PANEL 29019002900 DATED MARCH 17, 2011.
 - NATURAL GAS DISTRIBUTION TO BE DESIGNED BY AMEREN UE.
 - WATER DISTRIBUTION TO BE DESIGNED BY CONSOLIDATED PUBLIC WATER SUPPLY DISTRICT #1 OF BOONE COUNTY.
 - ELECTRIC DISTRIBUTION TO BE DESIGNED BY THE BOONE ELECTRIC COOPERATIVE.
 - LOT NUMBERS SHOWN ARE FOR INVENTORY PURPOSES ONLY.
 - THE EXISTING ZONING OF THIS TRACT IS R-1.
 - THIS PLAT CONTAINS 22.6 ACRES.
 - THIS TRACT WAS PRELIMINARY PLATTED PRIOR TO THE STREAM BUFFER REQUIREMENTS IN SECTION 12A-230, AND IS THEREFOR EXEMPT FROM THE STREAM BUFFER REQUIREMENTS.
 - ALL STORM SEWER AND WATER QUALITY DESIGN SHALL MEET THE CITY OF COLUMBIA STORM WATER MANUAL & REGULATIONS.
 - LOTS C1, C2 & C3 ARE NOT FOR RESIDENTIAL DEVELOPMENT, BUT MAY CONTAIN NEIGHBORHOOD AMENITIES SUCH AS RECREATIONAL FACILITIES, SHELTERS, STORM WATER FEATURES, ECT. AND ARE TO BE DEDICATED TO THE HOME OWNERS ASSOCIATION.
 - A MINIMUM OF 25% OF THE TREES CLASSIFIED AS CLIMAX FOREST AND LOCATED ON THIS TRACT SHALL BE PRESERVED. A TREE PRESERVATION PLAN SHALL BE SUBMITTED AND APPROVED BY THE CITY ARBORIST PRIOR TO PLAN APPROVAL.
 - THE INTENT IS FOR THIS DEVELOPMENT TO BE DEVELOPED IN ONE PHASE, HOWEVER MULTIPLE PHASES WOULD BE ALLOWED.

BASIS OF BEARING:
BEARINGS ARE REFERENCED TO GRID NORTH, OF THE MISSOURI STATE PLANE COORDINATE SYSTEM (CENTRAL ZONE), OBTAINED FROM GPS OBSERVATION.

LEGAL DESCRIPTION:
A TRACT OF LAND LOCATED IN THE NORTH HALF OF SECTION 2, TOWNSHIP 47 NORTH, RANGE 13 WEST, COLUMBIA, BOONE COUNTY, MISSOURI AND BEING PARCEL 1 OF THE LAND DESCRIBED BY THE WARRANTY DEED RECORDED IN BOOK 4430, PAGE 143 AND BEING PART OF THE SURVEY RECORDED IN BOOK 297, PAGE 303 AND CONTAINING 21.04 ACRES.

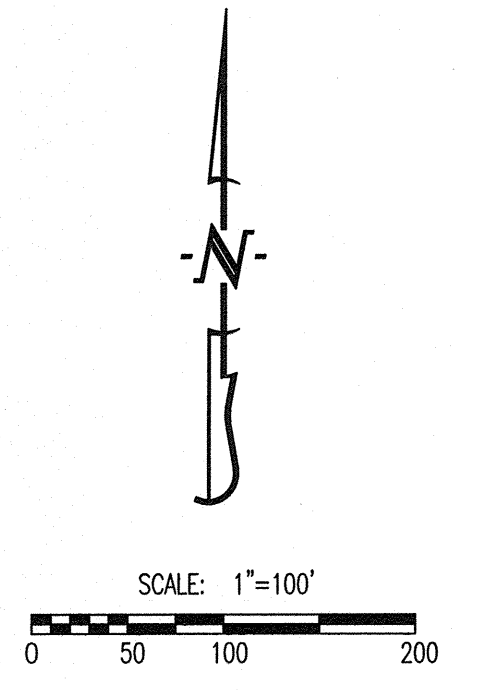

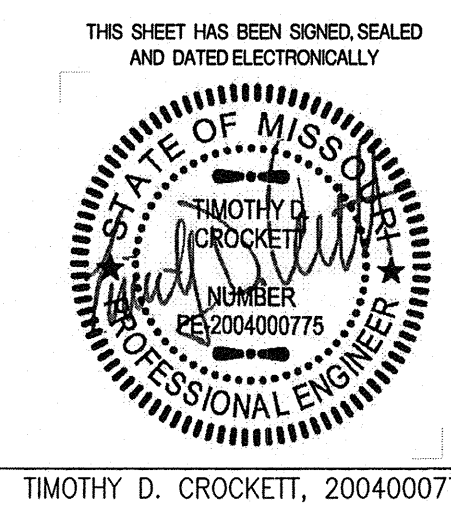
