Re: Capacity Building Services

## Executive Summary

A resolution authorizing the City Manager to sign an agreement for services between Heart of Missouri United Way and the City of Columbia, MO.

## Discussion

The City of Columbia received \$25.2 million in American Rescue Plan Act (ARPA) funds to address the public health and economic impacts of the COVID-19 pandemic. On October 2, 2023, the City Council approved a resolution that instructed staff to negotiate agreements for Council consideration utilizing the ARPA funds. This agreement with the Heart of Missouri United Way (HMUW) addresses the capacity building needs for nonprofit organizations within our community that will receive grant funding.

HMUW will provide assistance to local nonprofit organizations to build their capacity to achieve their mission and better serve the city of Columbia community, by aiding in developing and strengthening the skills, abilities, processes and resources that the non-profit organizations need to do so. HMUW's services will help local non-profit organizations build their overall local nonprofit capacity, aid in the implementation and assessment of targeted improvements to advance their overall effectiveness, deliver strong programs, and pursue grant-funding opportunities.

Under this agreement, HMUW will administer a core capacity building assessment tool (CCAT) to organizations seeking to build their current capacity. Once this assessment is preformed, funding will be granted based on alignment with the results of the individual organization's priority target area for capacity, as identified through the CCAT. The annual agreement is for \$138,000 and the city may renew the agreement for up to 2 additional successive 1-year terms.

## Fiscal Impact

Short-Term Impact: This would issue \$138,000 for a project which is funded with City ARPA funds.

Long-Term Impact: \$276,000
