**AN ORDINANCE**

amending the FY 2016 Annual Budget by adding and deleting positions in the Utilities Department – Solid Waste Administration Division; amending the FY 2016 Classification and Pay Plan by adding and deleting a position and by making a classification market adjustment; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2016 Annual Budget adopted by Ordinance No. 022570 is amended by adding the following positions to the Utilities Department – Solid Waste Division authorized personnel:
