Re: Authorizing and Ratifying a Second Amended Agreement with Boone County, Missouri

for Administration of CARES Funding for Public Safety Employee Expenses

#### **Executive Summary**

An ordinance has been prepared to ratify a second amended agreement for CARES funding with Boone County related to an increase in funds for public safety funding.

#### Discussion

The City and the County have previously entered into four (4) contracts for CARES Act Funding from the Boone County allocation. As amended, those contracts provide for the following expense reimbursements to the City:

- Public health funding in the amount of \$2,285,489.98 (authorized by Ordinance No. 024496 (B1-21); amended by Ordinance No. 0245819 (B88-21));
- Public entity PPE funding in the amount of \$167,404.26 (authorized by Ordinance No. 024496 (B1-21); amended by Ordinance No. 024581 (B88-21)); and
- Public safety funding in the amount of \$2,895,345.04 (authorized by Ordinance No. 024496 (B1-21); amended by Ordinance No. 024581 (B88-21)).

The attached second amended agreement for CARES funding is applicable to the public safety funding agreement and would increase the funding for public safety expense reimbursement in the amount of \$1,344,860.98 for a new contract not-to-exceed amount of \$4,240,206.02. The City has previously provided the County with sufficient documentation of expenditures for public safety expenditures to qualify for this additional reimbursement.

Because this agreement and the related expenditures are directly related to the declared state of emergency within the City due to the COVID-19 pandemic, the City Manager utilized the powers authorized by Chapter 7 of the City Code to execute the agreement in advance of the City Council meeting at which the agreement is presented to Council for ratification.
