AN ORDINANCE

rezoning property located on the east and west sides of Fairview Road and north of Worley Street (700 N. Fairview Road) from District A (Agriculture) and District R-1 (One-family Dwelling) to District M-C (Mixed-use Corridor); repealing all conflicting ordinances or parts of ordinances; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The "Official Zoning Map of the City of Columbia, Missouri" established and adopted by Section 29-1.4 of the Code of Ordinances of the City of Columbia, Missouri, is amended so that the following property will be rezoned and become a part of District M-C (Mixed-use Corridor) and taken away from District A (Agriculture) and District R-1 (One-family Dwelling):

N10°23'00"W, 4.55 FEET; THENCE S77°51'50"W, 52.02 FEET; THENCE N14°07'30"W, 4.90 FEET; THENCE S78°58'20"W, 13.95 FEET; THENCE S12°13'00"E, 4.83 FEET; THENCE 83.12 FEET ALONG A 61.00-FOOT RADIUS NON-TANGENT CURVE TO THE RIGHT, SAID CURVE HAVING A CHORD, N55°41'30"W, 76.84 FEET; THENCE N16°39'10"W, 45.55 FEET; THENCE S73°20'50"W, 5.57 FEET TO THE EAST LINE OF THE STREET EASEMENT RECORDED IN BOOK 519, PAGE 757; THENCE WITH SAID EAST LINE. 102.97 FEET ALONG A 539.96-FOOT RADIUS NON-TANGENT CURVE TO THE RIGHT, SAID CURVE HAVING A CHORD, N10°43'40"W, 102.81 FEET TO THE QUARTER SECTION LINE; THENCE WITH SAID QUARTER SECTION LINE, N83°28'35"W, 90.43 FEET TO THE POINT OF BEGINNING AND CONTAINING 24.23 ACRES

BEARINGS ARE REFERENCED TO GRID NORTH OF THE MISSOURI STATE PLANE COORDINATE SYSTEM (CENTRAL ZONE) FROM GPS OBSERVATIONS.

SECTION 2. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. This ordinance shall be in full force and effect from and after its passage.
