AN ORDINANCE

authorizing an agreement with Boone County, Missouri for the Live Well Boone County pilot program; amending the FY 2016 Annual Budget by adding positions in the Public Health and Human Services Department; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute an agreement with Boone County, Missouri for the Live Well Boone County pilot program. The form and content of the agreement shall be substantially in the same form as set forth in "Exhibit A" attached hereto.

SECTION 2. The FY 2016 Annual Budget adopted by Ordinance No. 022570 is amended by adding the following positions to the Public Health and Human Services Department authorized personnel:

Public Health and Human Services Department – Community Health Promotion Division

1.00 FTE 7303 Health Educator Grade C5 Exempt

Public Health and Human Services – Human Services Division

1.00 FTE 7301 Social Services Clinic Specialist Grade C4 Non-Exempt

SECTION 3. The sum of \$164,931.12 is hereby appropriated from Account No. 110-3030-463.10-00 GLWBC, the sum of \$101,360.00 is hereby appropriated from Account No. 110-4440-463.10-00 GLWBC and the sum of \$67,400.00 is hereby appropriated from Account No. 110-3010-463.02-00 GLWBC in the amounts and to the accounts as follows:


