**AN ORDINANCE**

amending Chapter 17 of the City Code as it relates to Parks and Recreation fees; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. Chapter 17 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

Sec. 17-161. Fees.

The following parks and recreation fees are hereby established:

(h) Athletic Field Rentals. In addition to the recreation facility use charge under section (o)(2).

Football/Lacrosse fields—Per field

- (1) Fields without lights and irrigated
  - Rate, per game, ~~per field~~ ..... 54.00
  - Rate, per day ..... 122.00
- (2) Fields with lights and irrigated
  - Rate, per game ..... 70.00
  - Rate, per day, ~~per field~~ ..... ~~122.00~~ 168.00

Soccer—Per field

- (1) Fields without lights and irrigated ~~1, 2, 3 and 6~~
  - Rate, ~~Per~~ per game ..... 54.00

SECTION 2. This ordinance shall be in full force and effect from and after October 1, 2018.


