Re: REPORT - Final Report of Mayor's Task Force on Pedestrian Safety (Case #16-100)

Executive Summary

As this is a report, no immediate action is necessary. Future Council actions may include direction to staff to proceed with implementation of specific recommendations included in the report.

Discussion

Due to a large number of pedestrian fatalities and injuries in collisions with motor vehicles in late 2014 and early 2015, Mayor Robert McDavid and the City Council established the Mayor's Task Force on Pedestrian Safety at the May 18, 2015 Council meeting. Fifteen citizens of Columbia were appointed to the Task Force at the June 1, 2015 Council meeting. The Task Force was co-chaired by Council members Clyde Ruffin and Ian Thomas. The Task Force's mission was to make recommendations to the Council on what actions might be taken to reduce pedestrian-motor vehicle collisions and improve pedestrian safety overall. The Task Force began meeting in June, 2015, and held their final meeting on March 22, 2015. The meetings included a number of presentations from City departments and other citizens on specific elements of the pedestrian safety issue. For the November, December, and January meetings, the Task Force broke into three subcommittees to address the separate aspects of engineering, education, and enforcement as they relate to the pedestrian safety issue. Each of the subcommittees also included additional citizens who volunteered their time to participate. The attached final report and recommendations is the result of the Task Force's extensive work.
