ADOPT A SPOT AGREEMENT

THIS AGREEMENT is entered into on the date of the last signatory noted below (the "Effective Date"), by and between the City of Columbia, Missouri, a municipal corporation (hereinafter "City"), and Rebecca Childers, BHS Spartan Alliance (hereinafter "Adopter").

The parties agree as follows:

- 8. Nothing in this Agreement shall be deemed to be a waiver or limitation of City's rights and defenses with regard to applicable sovereign, governmental or official immunities and protections as provided by federal and state constitution and laws.
- 9. In the event Adopter is a corporation, company, organization, club, association, or group of any type, Adopter shall explain the terms and waivers contained in this Agreement to those persons who will be doing the tasks required.

10. This Agreement may be signed in one (1) or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same document.
