Re: Authorizing a second amendment to the Community Development Block Grant (CDBG)

Agreement for Reallocated Funds with Job Point

#### **Executive Summary**

Approval of the resolution will authorize the City Manager to execute a second amendment to the Community Development Block Grant (CDBG) Agreement for fiscal year (FY) 2021 and FY 2022 Reallocated Funds with Job Point in order to extend Job Point's authorized time period for completing work and expending funds

#### Discussion

On January 17, 2024, following City Council authorization, the City entered into a funding agreement for \$102,000 in reallocated FY 2021 and FY 2022 CDBG funds with Job Point ("the Agreement") for renovations to Job Point's facility located at 400 Wilkes Boulevard. Under the original agreement, Job Point agreed to have 50% of the funds expended by March 31, 2024 and all work completed and funds expended by April 30, 2024.

On April 1, 2024, City Council authorized a first amendment to the Agreement to extend the above timeframes to May 30, 2024 (50% of funds expended) and July 31, 2024 (all work completed and funds expended). This extension was needed due to the length of time the environmental review and submission process took with the U.S. Department of Housing and Urban Development (HUD).

Job Point is now requesting a second amendment to further extend the timeframes to July 15, 2024 (50% of funds expended) and September 30, 2024 (all work completed and funds expended). This extension is requested due the additional time it has taken Job Point to work through the federal contracting process required by HUD, including compliance with the Davis-Bacon Act.
