IX. FUNDING APPLICATIONS (To begin at 5:15 p.m.)

Explanation of Process

As each applicant summary is introduced in reverse alpha order by organization representatives present, staff will state the agency's name, title of the project, amount requested, conflicts of interest, and stipulations if funded, along with the average score (after dropping highest and lowest). Discussion may be introduced on each application. If organization has provided a written response to OCA staff about any factually inaccurate evaluation comments, staff will share the response prior to any discussion.

If there is a conflict of interest, that Commissioner will abstain from discussion while the application is reviewed, but remain in the room.

Discussion should focus on the application, not the agency, and the guidelines and criteria of the funding program.

If a Commissioner wishes to change a score, they should do so once the discussion on that application occurs. Once we have reviewed all applications, Commissioners can turn their score changes in to Kristina.

After all applications are reviewed, staff will make any changes to the scores and refigure the ranking (after the meeting).

At the conclusion of tonight's meeting, no more changes can be made to scores. At the July meeting, the Commission will accept the finalized scores and rankings.

Any application receiving a combined score of 59 or less, will not be funded; currently all applications are scoring above that.

Special note to organization representatives: Although comments from the organizations will not occur at this meeting, applicants had the opportunity to give feedback to staff after receiving the evaluation comments last week. Representatives present may be asked a question to clarify a point of their application; however, there will not be a dialogue at this time.

Available Funds

Dresser stated that while the dollar amount for allocation has not been finalized at this time, the budget request of \$100,000 for FY20 annual arts funding received approval from the City Manager at OCA's budget meeting in May (this does not include the amount that will be distributed from the CAF). It was emphasized that recommended funding levels will be considered preliminary until the City's budget as a whole is approved in September by City Council. In addition, \$3,000 has been budgeted for Small Request funding in FY20. Pending the CAF Advisory Committee decision, there will be an additional \$9,780 from the fund.

Finalize Scores

Staff will be using the new formula to determine funding levels this week and the Commissioners will be given the results by early next week. The Formula used is: Amount Requested x total average score (dropping high & low) x adjusting percentage (available funding/request total). For the top three scoring applications at or above 95%, a bonus award of \$500 will be allocated.

Letters will be mailed listing the funding levels will be sent after the public hearing meeting in July, along with individualized packets of Commissioner scores and comments. Vianello announced that audience members are welcome to attend the July Commission meeting and exercise their opportunity to address the Commission about the funding process.
