Re: 2025 Byrne Justice Assistance Grant (JAG): Intergovernmental Agreement

Impacted Ward: Citywide

Executive Summary

The purpose of this ordinance is to offer the intergovernmental agreement between the County of Boone, Missouri and City of Columbia, Missouri for a 40-60% split of available funds on the established disparity formula. This will result in the City's share of funds being \$28,818.60 to purchase equipment.

Discussion

Through a written, signed agreement between the City of Columbia, Missouri and County of Boone, Missouri, an award in the form of a grant for law enforcement equipment could be obtained. This action is not acceptance of the funding. This is one of the necessary steps to comply with the application conditions.

This grant, if awarded, will support the purchase of CSI camera kits for crime scene documentation, K9 bite suits to replace aging training equipment, public information media equipment for community outreach and emergency messaging, and a GNSS receiver with software for mapping and documenting serious injury and fatal crash scenes. This equipment will enhance investigative capabilities, training safety, and public communication efforts.

Fiscal Impact

Short-Term Impact: \$28,818.60 will be the Columbia Police Department's share of this grant's funding. \$25,000 revenue and expense were included in the FY 2026 Police budget, a budget amendment for the additional \$3,818.60 in both revenue and expense will be done once grant is awarded.

Long-Term Impact: There will be no additional cost to the city for the years after two.
