

Introduced by Buffaloe Council Bill No. R 26-25

### A RESOLUTION

setting a public hearing; declaring the necessity for the proposed construction of street and sidewalk improvements along Garth Avenue, between Texas Avenue and Thurman Street; stating the nature of and the estimate of the cost of the proposed improvement; providing source of funds for payment for the proposed improvement; and providing for compliance with the prevailing wage law.

WHEREAS, interested parties meetings for the proposed construction of street and sidewalk improvements along Garth Avenue, between Texas Avenue and Thurman Street, were held by the Public Works Department on August 8, 2023 and February 26, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. A public hearing in respect to the proposed public improvements set forth herein will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on April 21, 2025. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

SECTION 2. The City Council deems the proposed construction of street and sidewalk improvements along Garth Avenue, between Texas Avenue and Thurman Street, necessary to the welfare and improvement of the City but desires to hear from the public prior to taking further action to authorize construction of the project. Specific improvements include reconstruction of failing pavement panels, curbs, and sidewalk sections, construction of a sidewalk along a portion of the east side of Garth Avenue to fill-in two (2) sidewalk gaps, and construction of an asphalt overlay along Garth Avenue between Texas Avenue and Thurman Street.

SECTION 3. The nature and scope of the proposed improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements. Following the public hearing the City Council shall determine whether it is in the public interest to make the proposed public improvements or any part thereof.

SECTION 4. The estimated cost of this proposed improvement is \$1,627,700.00.

SECTION 5. Payment for this proposed improvement shall be made from quarter-cent Capital Improvement Program (CIP) sales tax funds, county road tax funds, and such other funds as may be lawfully appropriated.

SECTION 6. Any work done in connection with the construction of the proposed improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.
