

Introduced by Buffaloe Council Bill No. R 65-22

**A RESOLUTION**

authorizing the temporary closure of a sidewalk on University Avenue between Ninth Street and Hitt Street to facilitate the demolition of The Professional Building on the University of Missouri campus, and the temporary closure of vehicular lanes, parking lanes and sidewalks on Sixth Street between Elm Street and Stewart Road to facilitate the demolition of Parker Hall, Noyes Hall and the Old Student Health Building on the University of Missouri campus.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby authorizes the University of Missouri the following temporary sidewalk, vehicular lane and parking lane closures, as shown on "Exhibit A" and "Exhibit B" attached hereto, to facilitate the demolition of The Professional Building, Parker Hall, Noyes Hall, and the Old Student Health Building on the University of Missouri campus:

1. Closure of the sidewalk on the north side of University Avenue, between Ninth Street and Hitt Street, as shown on "Exhibit A" attached hereto, from June 6, 2022 through October 7, 2022 to facilitate the demolition of The Professional Building.
2. Restrictions of both vehicular lanes and closures of both parking lanes and the sidewalk on the east side of Sixth Street, between Elm Street and Stewart Road, as shown on "Exhibit B" attached hereto, from June 13, 2022 through October 7, 2022 to facilitate the demolition of Parker Hall, Noyes Hall, and the Old Student Health Building.


SECTION 2. The University of Missouri shall close the sidewalks, vehicular lanes and parking lanes only in accordance with the traffic control plans submitted and approved by the City's Director of Public Works. In the interest of public safety, the Director of Public Works may require additional traffic control measures by notifying The University of Missouri, in writing, of such requirements. The University of Missouri shall be responsible for all signs and barricades necessary for the protection and convenience of the general public and shall be responsible for the repair of the sidewalks, vehicular lanes and parking lanes due to any damage caused by the demolition activity. The University of Missouri shall be responsible for notifications to the media and emergency personnel.

SECTION 3. The University of Missouri shall proceed with demolition activities which require the temporary sidewalk, vehicular lane and parking lane closures without unnecessary delay so as to minimize disruption to the public. Failure to proceed without unnecessary delay may result in the revocation of the closure permit by the City Council.

SECTION 4. The temporary closures authorized herein may be terminated by the City Council upon recommendation of the Director of Public Works and a determination such closures are no longer necessary for the protection of the health, safety and welfare of the public or is otherwise in the best interest of the public.
