 TANDY'S ADDITION TO THE CITY OF COLUMBIA, MO. IS IN THE NORTHWEST QUARTER OF SEC. 7, TOWNSHIP 48, RANGE 12, AND IS BOUNDED AS FOLLOWS: BEGINNING AT A POINT ON THE NORTH LINE OF SAID SEC. 7 18.14 CHAINS EAST OF THE NORTHWEST CORNER OF SAID SEC., THENCE WEST 9.14 CHAINS, THENCE SOUTH 10.15 CHAINS, THENCE EAST 4 FEET, THENCE SOUTH 11.96 CHAINS, THENCE SOUTH 88°23' WEST 44.6 FEET, THENCE SOUTH 109.5 FEET, THENCE EAST 559.5, THENCE IN A NORTHEAST DIRECTION 74.5 FEET TO A POINT 1551.1 FEET SOUTH OF THE BEGINNING, THENCE NORTH 1551.1 FEET TO THE BEGINNING. WHICH SAID ADDITION IS LAID OFF INTO LOTS OF THE DIMENSIONS EXHIBED BY THE ACCOMPANYING PLAT, ALSO THE STREETS AND ALLEYS AS THEREON MARKED AND DESCRIBED; WHICH SAID STREET AND ALLEYS ARE HEREBY CONVEYED TO THE INHABITANTS OF THE CITY OF COLUMBIA, MO., AS PUBLIC PASSWAYS AND AVENUES, AND FOR NO OTHER PURPOSE.
