Re: North 763 CID Board of Directors – Annual Membership

Executive Summary

The North 763 Community Improvement District (CID) Board of Directors has submitted proposed Board of Director members to the Mayor for consideration for appointment.

Discussion

The North 763 CID was established by ordinance on December 15, 2018, and it provided for five Board of Directors members. The initial five members were appointed by the ordinance/petition establishing the North 763 CID to staggering terms of two and four years.

Current Board of Director members are: Roger Moser (Term ending December 14, 2024) Robert Walters (Term ending December 14, 2024) Brad Denomme (Term ending December 14, 2026) Abigail Anderson (Term ending December 14, 2026) Jay Manda (Term ending December 14, 2026)

The qualifications to serve on the Board of Directors are set out in the North 763 CID petition and state law. It is required that each director be at least 18 years of age and be either an owner of real property within the District, an owner of a business operating within the District, or a registered voter residing in the District, all as defined in the CID Act (Section 67.1401 RSMo. et seq.).

The petition governing the formation of the North 763 CID provides the appointment process of members to the Board of Directors, "successor directors shall be appointed by the Mayor of the City of Columbia and confirmed by the City Council for all successor directors to be chosen from the eligible property owners, business owners, or registered voters within the District."

The North 763 is suggesting that Roger Moser and Robert Walters be appointed for terms beginning December 15, 2024 and ending December 14, 2028, and that Amy Dalton be appointed to replace Abigail Anderson who has vacated her position. Amy Dalton would serve the remainder of that term, which ends December 14, 2026.
