

**THIRD AMENDMENT  
to the  
2024 AGREEMENT**

This Third Amendment to the 2024 Agreement between the **CITY OF COLUMBIA** ("CITY"), and FIRST LAST MILE VALET SERVICE, ("Provider") is made as of the date of the last signatory noted below ("Amendment Effective Date").

**RECITALS**

- A. WHEREAS, on January 17, 2024, CITY and Provider entered into an Agreement for transportation services ("2024 Agreement"); and
- B. WHEREAS, on February 6, 2024, the Parties entered into a First Amendment to the 2024 Agreement ("First Amendment"); and
- C. WHEREAS, on December 17, 2024, the Parties entered into a Second Amendment to the 2024 Agreement ("Second Amendment"); and
- D. WHEREAS, the Parties hereto desire to formally amend the 2024 Agreement with this Third Amendment (hereinafter "Third Amendment") and desire to be bound by the terms contained in the 2024 Agreement as amended or supplemented by those terms contained in the First Amendment, Second Amendment and this Third Amendment.

**AMENDMENT**

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the 2024 Agreement, as amended by the First and Second Amendments, as follows:

- 1. Section 1.a. is hereby amended by deleting the phrase "residents of the City of Columbia" therefrom and inserting in lieu thereof the phrase "individuals located in the City of Columbia."
- 2. Section 8 is hereby amended to add the following subsection (f):  
"f. Provider is in need of additional start-up funding in the amount of one hundred thirteen thousand, nine hundred sixty-nine dollars (\$113,969.00). City will pay the start-up funding within fifteen days of the Third Amendment Effective Date. Provider shall use the start-up funding only for eligible and allowable costs in accordance with the American Rescue Plan Act of 2021, and related rules, regulations and guidance. The costs must be reasonable, allocable and properly documented."
- 3. Exhibit A shall be removed and replaced with the Exhibit A attached hereto.
- 4. All other terms of the 2024 Agreement, as amended, shall remain unchanged and in full force and effect.
