Re: The Food Bank for Central & Northeast Missouri, Inc.

## Executive Summary

A resolution authorizing the City Manager to sign an amendment to an agreement for services between The Food Bank for Central & Northeast Missouri, Inc. and the City of Columbia, MO.

## Discussion

The City of Columbia received \$25.2 million in American Rescue Plan Act (ARPA) funds to address the public health and economic impacts of the COVID-19 pandemic. On October 2, 2023, the City Council approved a resolution that instructed staff to negotiate agreements for Council consideration utilizing the ARPA funds. On December 4, 2023 Council authorized the City Manager to sign an agreement with The Food Bank for Central & Northeast Missouri, Inc. to address access to services. The original agreement was to provide 259,067 pounds of food for City of Columbia households experiencing food insecurity. The original proposal for this project was for renovation, relocation, and rebranding of the Central Pantry. The Food Bank for Central & Northeast Missouri, Inc. made significant progress on the building prior to the execution of this agreement. Costs incurred prior to contract execution cannot be reimbursed with ARPA funds. Therefore, after conversations with The Food Bank for Central & Northeast Missouri, Inc., staff recommended pursuing a purchase of service model. The amendment will increase the total amount of the agreement from \$500,000 to \$633,333.33 and increase the pounds of food provided to City of Columbia households. The time period and other terms of the agreement will remain unchanged.

## Fiscal Impact

Short-Term Impact: This would issue an additional \$133,333.33 for a project which is funded with City ARPA funds.
