**MEMORANDUM OF AGREEMENT BETWEEN
THE ADJUTANT GENERAL AND
THE CITY OF COLUMBIA, MISSOURI**

SUBJECT: Request for Use of Land/Property for Missouri Army National Guard (MOARNG) Training Purposes (Private or Public Property)

1. Reference: MONG Policy Memo #19-43 dated 28 March 2019.
2. 835th CSSB/CBRN TF (hereinafter referred to as "Unit") requests authorization to use the land/property described below for official training purposes on 09-12 April 2026. All Soldiers will be in a proper military duty status during training activities.
3. The land/property is located at 5212 North Oakland Gravel Road, Bone County, Missouri, commonly known as the Northeast Regional Park, and the use will specifically include the Northeast Events Center, parking lots, and open space; and hereinafter referred to as "land/property" or "site". The owner/authorized representative is Gabe Huffington, gabe.huffington@como.gov, 573-874-6398. The City certifies lawful ownership or control of the land/property and is willing to allow Unit temporary use of the land/property on the dates listed above. Use of the land/property will not require payment or other valuable consideration to said Owner in order to permit Unit's use.
4. The training to be conducted on this land/property is vehicle and equipment parking, staging, display. Tent set up and tear down. Classroom education within the event center. 200 Soldiers will train in an IDT duty status on this land/property. HRF GSA's and civilian style tents will be used on this land/property. No other use, equipment or personnel will be authorized thereon unless specifically authorized in writing and agreed to by the Owner. CPT Richard Huelskoetter will be present throughout the training activities. CPT Huelskoetter and MSG Gregory Estep will be the OIC/NCOIC on site. This training cannot be conducted on existing MONG land/property and is critical to conducting effective training.
5. Training will include the use of the water hydrants on the property. There will be no chemicals or decontaminants used during training so water will remain as it is dispensed. Amount of water will be around 100 gallons and will be discharged slowly over the training period, 19-12 April. The system will not cause any erosion or flooding issues. Run off plan is to run the discharge hoses down the grade of the gravel to give the ground max capability in absorbing discharged water.

6. Task force personnel have visited the site for previous training exercises and are familiar with the training grounds. The unit representative discussed the following criteria with Gabe Huffington, 573-874-6398.

a. The use of this land/property will be a voluntary accommodation without cost to the MOARNG or the United States.

b. Services, supplies, or utilities will not be expected from Owner, nor will any reimbursement for such be provided by the MONG.

c. No services will be provided for the Owner in return for this use, and no other gratuity will be given by any member of the MONG.

d. Unit training will be limited to land specifically designated by the Owner, and these activities will not interfere with any known activities of the Owner.

e. Unit will not erect any permanent structures on the land, and all temporary structures and equipment will be promptly removed at the completion of the training.

f. MONG personnel will clean up and remove any debris and return the land/ property to its original state.

7. The MONG Training Record of Environmental Consideration (TREC) has been completed and is enclosed.

8. Hold Harmless Agreement: To the fullest extent not prohibited by law, and without waiving sovereign immunity, MONG shall indemnify and hold harmless the City of Columbia, its directors, officers, agents, and employees from and against all claims, damages, losses, and expenses (including but not limited to attorney's fees) for bodily injury and/or property damage arising by reason of any act or failure to act, negligent or otherwise, of MONG, of any subcontractor (meaning anyone, including but not limited to consultants having a contract with MONG or a subcontractor for part of the services), of anyone directly or indirectly employed by MONG or by any subcontractor, or of anyone for whose acts the MONG or its subcontractor may be liable including but not limited to volunteers, in connection with providing these services and its use of the Site. This provision does not, however, require MONG to indemnify, hold harmless, or defend the City of Columbia from the City's own negligence. This clause shall survive termination of the MOA.



"As Is" Condition of the Site: MONG accepts the Site in the existing "as is" condition and acknowledges that MONG does not rely on, and City does not make, any express or implied representations or warranties as to any matters, including but not limited to, any characteristics of the Site or improvements thereon, the suitability of the Site for the intended uses, the programmatic feasibility of MONG's use and occupancy of the Site, or the presence of any hazardous materials on or in the vicinity of the Site.
