**Executive Summary** 

Amending contract B337-13 between the City of Columbia and Tyler Technologies, LLC for the removal of the Tyler Incident Management (311), ERP Citizen Self Service and Tyler Content Manager Enterprise modules; the addition of Enterprise Permitting & Licensing Credit Card Payment API; and the addition of the ERP (Munis) API Toolkit Bundle.

#### Discussion

Tyler Technologies, LLC provides Enterprise software to the City supporting core financials, business licensing, permitting, and other services utilizing ERP (Munis) and EPL (EnerGov). We are requesting approval for the following items and have merged them into one amendment for ease.

1. Removal of the support and maintenance of the Tyler Incident Management, ERP Citizen Self Service and Tyler Content Manager Enterprise (TCM) modules. Tyler Incident Management was used to track citizen requests, such as potholes and street light repairs. This has been replaced with SeeClickFix. ERP Citizen Self Service was utilized for General Billing and Miscellaneous Cash Receipts, and has been replaced with Paylt. TCM provided a document management system for Tyler products. This has been replaced with Laserfiche. These Tyler modules are no longer in use and Tyler has removed them from our support contract, effective 9/30/24.

Annual cost savings of \$62,300.

2. The EnerGov Credit Card Payment API is needed to automate business license and permitting payments with Paylt.

Implementation cost of \$19,599 will be covered by existing funds. Recurring annual maintenance of \$2,400 will be covered by cost savings.

3. The API Toolkit bundle is needed to interface and integrate systems with ERP (Munis). The API Toolkit allows us to read and write data from and to Munis through a programming interface, streamlining business operations.

Implementation cost of \$84,400 will be covered by existing funds. Recurring annual maintenance of \$13,200 will be covered by cost savings.
