AN ORDINANCE

amending Chapter 2 of the City Code to create an Airport Department; amending Chapter 19 of the City Code as it relates to unclassified service; amending the FY 2026 Annual Budget Appendix - Authorized Full Time Equivalent (FTE) position identification summary; amending the FY 2026 Classification and Pay Plan by adding, reassigning, and retitling classifications; and fixing the time when this ordinance shall become effective.

Be it ordained by the Council of the City of Columbia, Missouri, as follows:

SECTION 1. Chapter 2 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

assistant city manager; deputy city counselor; prosecutor; assistant city counselor; assistant city prosecutor, internal auditor; sustainability manager; assistant fire chief; deputy fire chief; assistant police chief; deputy police chief; deputy city clerk; city management fellowship; cultural affairs manager; municipal court administrator; deputy court administrator; diversity, equity and inclusion administrator; ~~communications and creative services manager~~; assistant to the city manager; administrative services manager; ~~contact center and engagement manager~~; violence prevention administrator; executive assistant; deputy airport director manager.
