Re: Copperstone Plat 7B - Final Plat (Case #15-2019)

Executive Summary

Approval of "Copperstone Plat 7B" will result in the combination of two R-1 (One-family Dwelling) zoned lots.

Discussion

A Civil Group (agent), on behalf of Jennifer and David Ries (owners), seeks approval of a 1-lot final minor plat to be known as "Copperstone Plat 7B". The proposed replat combines Lots 116A and 117A of Copperstone Plat 7. The subject lots are located at 4602 and 4604 Copperstone Court, and contain a total of 1.65 acres. The lot at 4602 Copperstone Court is currently improved with a single-family residence, and 4604 is improved with a small pond. The purpose of the replat is to combine the two commonly-owned lots, into one.

No additional right of way for Copperstone Court is required at this time. Sidewalks along the parcel's street frontage have been installed. The site is served by all City utilities at this time, and no public utility extensions are required. Pursuant to Section 29-5.2(d)(4) of the UDC, the replat does not appear to create any detrimental impacts or remove any restrictions that were previously relied upon by adjacent property owners or the City.

It should be noted, during a prior public information meeting relating to another replat request within the Copperstone development concerns were expressed by a representative of the Copperstone Homeowners Association. The concern that was expressed indicated that consolidation of lots within the development effect the collection of Association fees which are based upon the total number of lots within the overall development. These fees were established by a separate private agreement. Pursuant to Section 29-1.7 of the UDC relating to enforcement of "Third-Party Private Agreements" the City is not obligated to enforce or ensure that Association fee collections are maintained.

Aside from the concern previously expressed by the Homeowners Association, to which the City is not a party, the plat has been reviewed by both internal staff and external agencies and has been found to comply with all applicable standards of the UDC.
