Re: Authorizing FY 2025 agreements with various arts and cultural organizations for arts

programming or services.

Executive Summary

This legislation authorizes 17 grant agreements with local arts and culture organizations for a total of \$50,000 in grant funding for arts programming.

Discussion

In FY25, a total of \$216,500 is budgeted for grants to local nonprofit arts organizations (\$200,000 from the Office of Cultural Affairs' (OCA) budget and \$16,500 from the Columbia Arts Fund endowment). \$166,500 in funding was granted through agreements with 26 organizations in October 2024. In December 2024, OCA opened a mid-year grant opportunity in order to distribute the remaining \$50,000, with an application deadline in January 2025.

The awards resulted from the Commission on Cultural Affairs review process of applications received from local arts organizations. Commissioners reviewed the project proposals and made award level recommendations at its March 10, 2025 meeting. The 17 grant agreements provide funding for various arts and cultural programs, scheduled May 2025 through October 2025. The following is a list of organizations, projects, and award amounts:
