Re: Resolution setting a public hearing to consider the FY 2026 Community Development Block Grant (CDBG) and HOME Investment Partnership (HOME) Annual Action Plan for May 18, 2026

Impacted Ward: Citywide

Executive Summary

The attached resolution sets a public hearing for May 18, 2026 to consider the FY 2026 CDBG and HOME Annual Action Plan. The FY 2026 Annual Action Plan must be submitted to the U.S. Department of Housing and Urban Development (HUD) by June 3, 2026. A public hearing is required by HUD in accordance with the City's Citizen Participation Plan. The 2026 Annual Action Plan is the 2nd year of implementing the 5-year Consolidated Plan for 2025-2029. A draft of the FY 2026 Annual Action Plan will be available for public comment from April 24, 2026 to May 26, 2026.

Discussion

Approval of the FY 2026 Annual Action Plan is required in order to receive CDBG and HOME program funding for FY 2026 projects. The Annual Action Plan identifies community development needs and funding priorities for FY 2026, the current CDBG and HOME program year. This year is the second year of the 2025-2029 Consolidated Plan, the five-year strategy for use of the CDBG and HOME. City staff was notified of final allocations on April 10, 2026. Notifications of funding awards have historically occurred between January and May. Communities receiving annual allocations of CDBG and HOME funds are statutorily required to submit annual action plans by August 16 and HUD's grant notice also requires cities to submit their annual action plans within 60 days of being notified of funding allocations. The attached resolution approves setting a public hearing for May 18, 2026 in order to move forward with implementing FY 2026 CDBG and HOME funding recommendations. The plan is also subject to a 30-day public comment period, which runs from April 24, 2026 to May 26, 2026, as provided in the notice prepared by staff. A public hearing must be held during this public comment period.
