Re: Resolution Authorizing an Agreement with "We Always Swing", Inc. for Tourism

Development Funds

Executive Summary

This resolution would authorize an agreement for Tourism Development Funds for the 2025 "We Always Swing" Jazz Series.

Discussion

Jon Poses, Executive Director of "We Always Swing", Inc. presented a Tourism Development Signature Series application to the Convention & Visitors Bureau (CVB) Advisory Board on October 28, 2024. Founded in 1995, the "We Always Swing" Jazz Series will celebrate its 30th Anniversary in 2025. The organization is one of the few well-respected, community-based jazz organizations in the Midwest. This milestone season will feature the Hilario Duran Quartet on March 20, 2025, at the Missouri Theatre. Duran, an internationally acclaimed pianist, composer, and bandleader, has received numerous awards for his work. On April 30, 2025, Bobby Watson, a renowned saxophonist, musician, and composer, will lead the 18-piece Columbia Jazz Orchestra in a special performance.

Additionally, "Jazz Appreciation Month" will be celebrated throughout April. Several events are being co-planned with local jazz organizations and schools to promote jazz and elevate Columbia's national profile as a prominent, jazz-friendly city.

The CVB Board reviewed and discussed the application, unanimously voting to recommend \$10,000 in tourism development funds to assist with promotions, marketing, and a portion of artists' fees.
