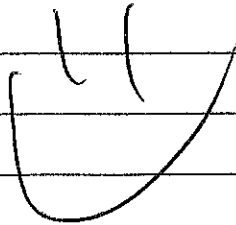

Some thoughts from Kevin Roberson, president of Friends of Rock Bridge :

All,

I am very much concerned about the 3 mile Southern Course. The majority of this race track is set in the area around Gans Creek that was specifically set aside as "Creek buffer and Natural Preservation Area" in the Gans Creek Recreation Area Masterplan. Gans Creek is a Missouri Outstanding Waterway and deserves to be protected, as the City had originally "promised" in their planning to get acceptance of this Park. I see no reason to allow this egregious incursion into what has previously been protected to allow for a mountain bike race track that is not protective in the least of this area. Please attend the meeting tomorrow or at least leave comments on the Beheard link.

Please stop by Thurs Aug 24, 5-7pm open house at Gans Creek Recreation Area 3100 Gans Road and say what you think about plans for a 7-mile mountain bike/walking trail (3 miles of which is on the north side of Gans Creek bordering Rock Bridge State Park.)
