BEGINNING AT THE NORTHEAST CORNER OF LOT 6, DISCOVERY PARK, PLAT NO. 6A RECORDED IN PLAT BOOK 58, PAGE 12 AND BEING ON THE SOUTHWEST RIGHT OF WAY LINE OF ARTEMIS DRIVE AND WITH THE NORTH LINE OF SAID LOT 6, S 49°06'40"W, 10.21 FEET; THENCE LEAVING SAID NORTH LINE AND WITH THE WEST LINE OF SAID UTILITY EASEMENT, 246.53 FEET ALONG A 270.00-FOOT RADIUS NON-TANGENT CURVE TO THE RIGHT, SAID CURVE HAVING A CHORD, N 3°15'35"W, 238.06 FEET; THENCE N 22°53'55"E, 199.84 FEET TO THE WEST LINE OF A 10 FOOT UTILITY EASEMENT RECORDED IN BOOK 5271, PAGE 99; THENCE WITH SAID WEST LINE, 10.66 FEET ALONG A 94.00-FOOT RADIUS NON-TANGENT CURVE TO THE LEFT, SAID CURVE HAVING A CHORD, S 45°10'00"E, 10.66 FEET; THENCE LEAVING SAID WEST LINE AND TRANSITIONING TO THE NORTHWEST RIGHT OF WAY LINE OF ARTEMIS DRIVE, 2.15 FEET ALONG A 20.00-FOOT RADIUS NON-TANGENT CURVE TO THE RIGHT, SAID CURVE HAVING A CHORD, S 19°49'05"W, 2.15 FEET; THENCE WITH SAID NORTHWEST RIGHT OF WAY LINE, S 22°53'55"W, 193.71 FEET; THENCE CONTINUING WITH SAID NORTHWEST RIGHT OF WAY LINE, 235.37 FEET ALONG A 260.00-FOOT RADIUS TANGENT CURVE TO THE LEFT, SAID CURVE HAVING A CHORD, S 3°02'05"E, 227.41 FEET TO THE POINT OF BEGINNING AND CONTAINING 4,386 SQUARE FEET.



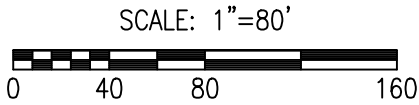
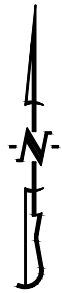
