## **Executive Summary**

Authorize the City Manager to execute an Airport Aid Agreement with Missouri Highways & Transportation Commission (MHTC) related to the relocation of Route H.

### Discussion

Staff is requesting Council authorize the City Manager to execute an Airport Aid Agreement with Missouri Highways & Transportation Commission (MHTC) to help fund the relocation of the Route H project. MHTC has agreed to provide fifty percent (50%) of the City's local ten percent (10%) match required by the Federal Aviation Administration (FAA) for the relocation of Route H. Therefore, staff is requesting that Council authorize the City Manager to execute the Airport Aid Agreement with MHTC that will allow the reimbursement in the amount of \$96,228.00.
