**AN ORDINANCE**

amending the FY 2022 Annual Budget by adding positions in the Department of Public Health and Human Services; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The FY 2022 Annual Budget adopted by Ordinance No. 024752 is amended by adding positions in the Public Health and Human Services Department as follows:
