

**CONTRACT AMENDMENT #2  
BOONE COUNTY AND CITY OF COLUMBIA  
ROAD MAINTENANCE AGREEMENT**

**Road Maintenance Responsibilities**

**THIS AGREEMENT** is entered into by and between **Boone County, Missouri**, through its County Commission, a political subdivision of the State of Missouri (hereinafter “County”), and the **City of Columbia, Missouri**, a political subdivision of the State of Missouri (hereinafter “City”) and is effective on the date of final execution as indicated below.

**WHEREAS**, County and City entered into a Road Maintenance Agreement approved by City of Columbia Ordinance 023682 on November 5, 2018 and Boone County Commission Order 502-2018 on November 13, 2018, and;

**WHEREAS**, the parties entered into Contract Amendment Number #1 of the Road Maintenance Agreement approved by City of Columbia Ordinance 024185 on March 2, 2020 and Boone County Commission Order 175-2020 on April 7, 2020, and

**WHEREAS**, the parties contemplated that the map incorporated into said Agreement would be updated to reflect changes in annexation, new road construction, and/or other factors which bear on the respective road maintenance responsibilities of the parties; and

**WHEREAS**, the parties desire to update the incorporated map by this Contract Amendment; and

**WHEREAS**, the parties desire to add Appendix ‘A’ to document in greater detail the annual changes, if any, to the road maintenance responsibilities of the parties by this Contract Amendment.

**NOW, THEREFORE**, in consideration of the mutual covenants, promises and representations in this agreement, the parties agree to the following:

1. MAP: The attached map dated **03/13/2026** shall update and replace the map dated November 26, 2019 in the Amendment #1 to the original agreement.
2. APPENDIX ‘A’: The attached Appendix ‘A’ shall be added to document in greater detail the annual changes, if any, to the road maintenance responsibilities of the parties.
3. OTHER PROVISIONS OF AGREEMENT UNCHANGED: Except as specifically amended above, all other terms, conditions, and provisions of the original agreement shall remain in full force and effect.

**IN WITNESS WHEREOF** the parties, through their duly authorize representatives, have executed this agreement effective as of the date of the last party and execute the same.

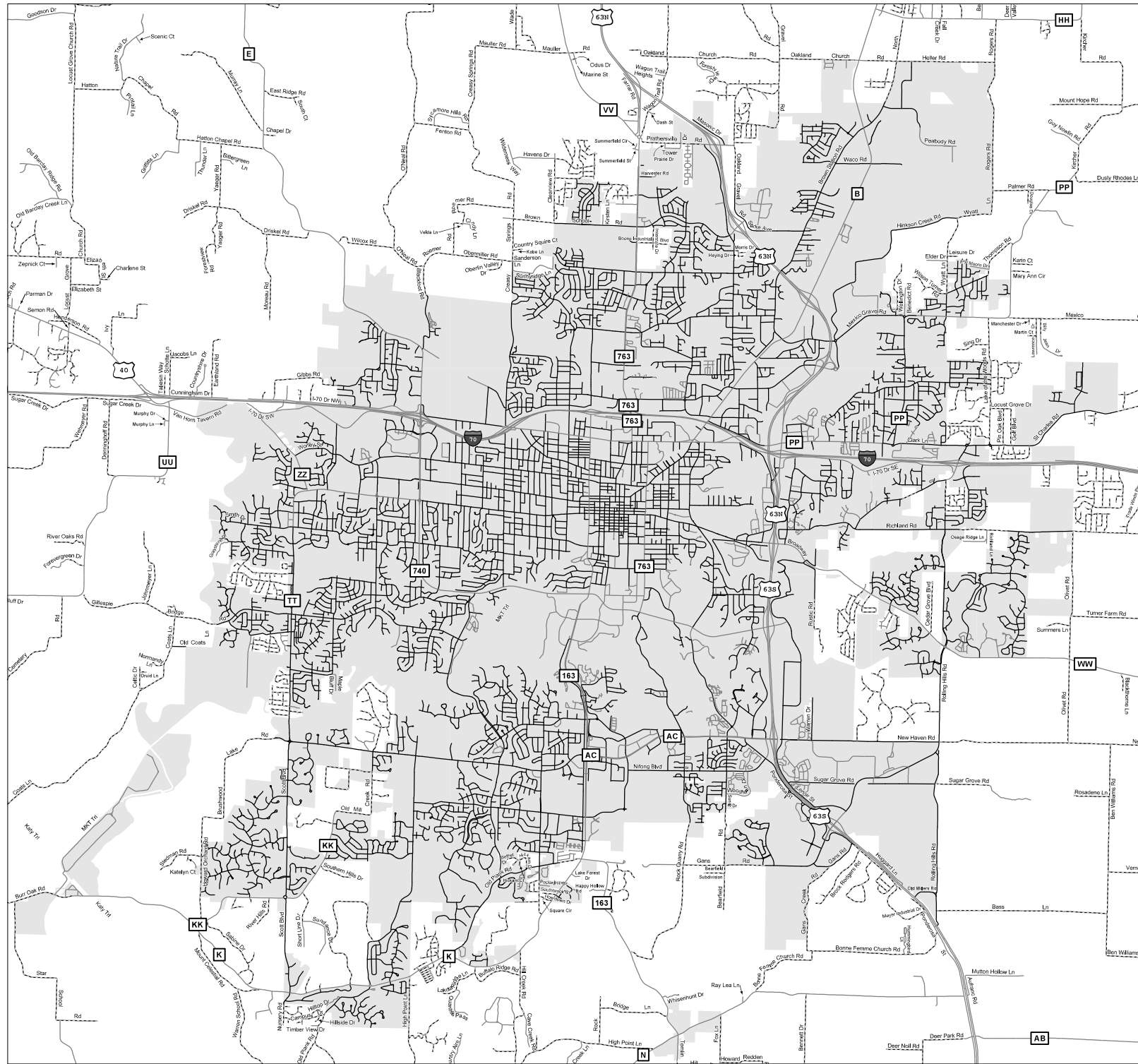

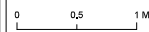

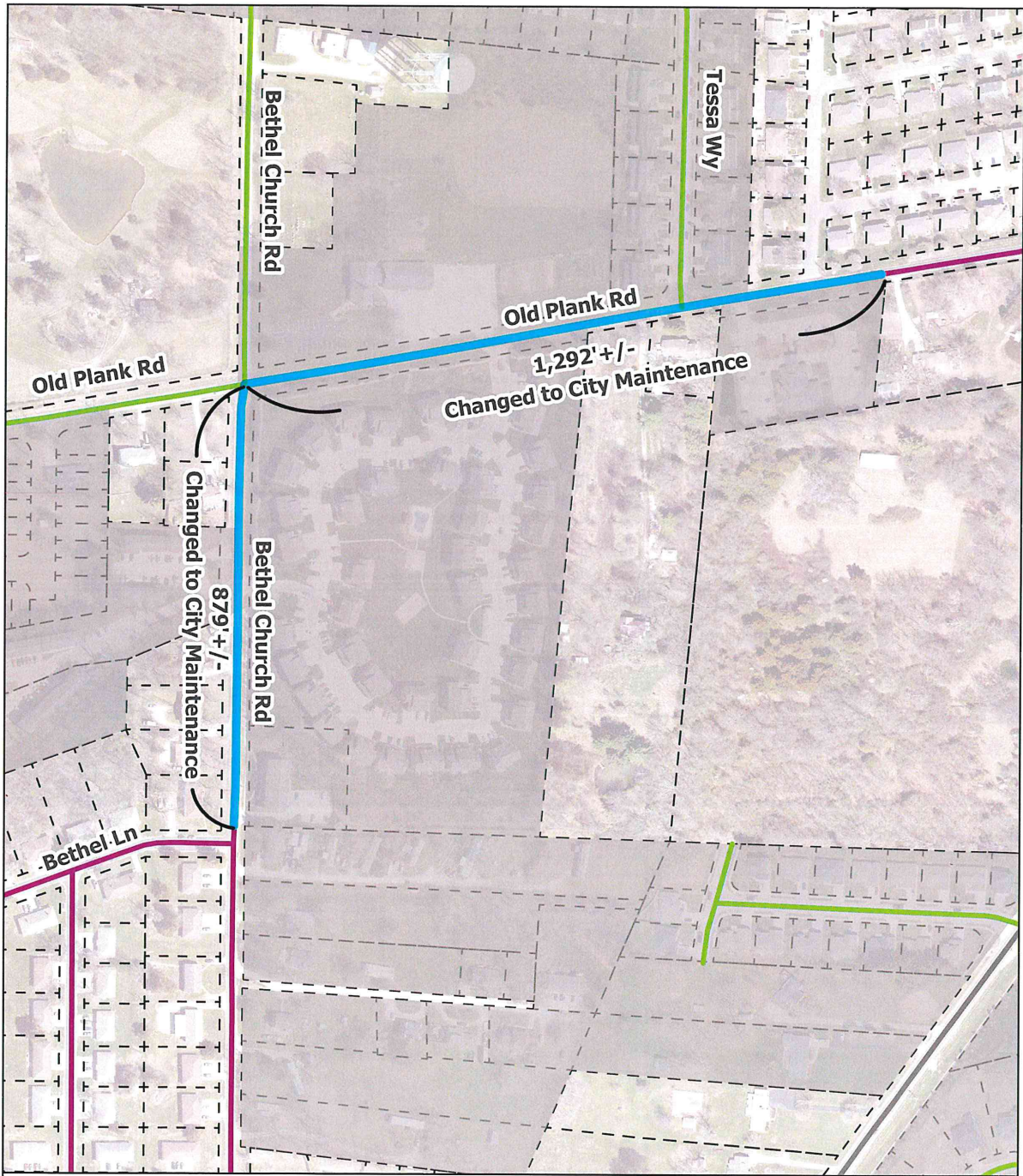
