## AN ORDINANCE

extending the corporate limits of the City of Columbia, Missouri, by annexing property located on the northwest corner of the Prathersville Road and Oakland Gravel Road intersection; directing the City Clerk to give notice of the annexation; placing a portion of the property annexed in District R-1 (One-Family Dwelling District), District M-N (Mixed Use-Neighborhood District) and District M-C (Mixed Use-Corridor District) zoning; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby finds that a verified petition was filed with the City on October 25, 2018, requesting the annexation of land which is contiguous and compact to the existing corporate limits of the City and which is described in Section 4 of this ordinance. The petition was signed by Gary G. Ridenhour, the sole owner of the fee interest of record in the land proposed to be annexed. A public hearing was held concerning this matter on November 19, 2018. Notice of this hearing was published more than seven days prior to the hearing in a newspaper of general circulation qualified to publish legal matters. At the public hearing all interested persons, corporations and political subdivisions were permitted to present evidence regarding the proposed annexation.

SECTION 2. The Council determines that the annexation is reasonable and necessary to the proper development of the City and that the City has the ability to furnish normal municipal services to the area to be annexed within a reasonable time.

SECTION 3. The Council determines that no written objection to the proposed annexation has been filed within fourteen days after the public hearing.

SECTION 4. The City Council hereby extends the city limits by annexing the land described in Section 1-11.\_\_ [number to be assigned by the City Clerk] of the Code of Ordinances of the City of Columbia, Missouri, which is hereby added to Chapter 1 of the City Code and which reads as follows:

Section 1-11.\_\_ [number to be assigned by the City Clerk]. December, 2018 Extension of Corporate Limits.
