## **AN ORDINANCE**

adopting amended FY 2026 Classification and Pay Plans; establishing implementation dates of November 23, 2025 and January 18, 2026; amending Chapter 19 of the City Code as it relates to vacation leave; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby adopts an amended FY 2026 Classification and Pay Plan, which is attached to this ordinance as "Exhibit A." The amended FY 2026 Classification and Pay Plan and salary adjustments set forth herein shall be effective as of the pay period beginning on November 23, 2025. The amended FY 2026 Classification and Pay Plan replaces the Classification and Pay Plan attached to Ordinance No. 026103 passed on September 15, 2025.

SECTION 2. The City Council adopts an amended FY 2026 Classification and Pay Plan that contains an across the board increase of 1.5% per hour, which is attached to this ordinance as "Exhibit B." The amended FY 2026 Classification and Pay Plan set forth herein shall be effective as of January 18, 2026, and shall replace the Classification and Pay Plan adopted in Section 1 (Exhibit A) as of that date.

SECTION 3. Chapter 19 of the Code of Ordinances of the City of Columbia, Missouri, is hereby amended as follows:

(a) Vacation shall be earned and accumulated by pay periods and granted on the last day of each pay period in hourly amounts accrued according to the following charts:
