The City Council of the City of Columbia, Missouri met for a regular meeting at 7:00 p.m. on Monday, October 17, 2022, in the Council Chamber of the City of Columbia, Missouri. The Council and staff discussed various topics to include the discontinuation of the practice of 4 p.m. comments, which began at the beginning the pandemic, the need for a work session to discuss the next steps with regard to the Citizens Police Review Board (CPRB) in terms of training and onboarding, which might result in a joint session with the CPRB members at a later date, and Council Member Fowler meeting with City staff and the Downtown Community Improvement District (CID) regarding the downtown solid waste master plan.
