AN ORDINANCE

authorizing a program services contract with the Missouri Department of Health and Senior Services for the epidemiology and laboratory capacity community health worker initiative; amending the FY 2022 Annual Budget by adding positions in the Department of Public Health and Human Services; appropriating funds; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is hereby authorized to execute a program services contract with the Missouri Department of Health and Senior Services for the epidemiology and laboratory capacity community health worker initiative. The form and content of the program services contract shall be substantially as set forth in "Exhibit A" attached hereto and made a part hereof. Any actions taken by or on behalf of the City in connection with such agreement prior to the date of this ordinance are hereby approved and ratified.

SECTION 2. The FY 2022 Annual Budget adopted by Ordinance No. 024752 is amended by adding positions in the Department of Public Health and Human Services as follows:

3.00 FTE	7305 Community Health Worker	Grade C3	Non-Exempt
1.00 FTE	7306 Community Health Worker Supervisor	Grade D6	Exempt
