Executive Summary

Staff has prepared for Council consideration a resolution authorizing the City Manager to sign an agreement with Green Valley Rifle & Pistol Club, Inc. or "Green Valley" for the use of their facilities by Columbia Police Department for FY2026.

Discussion

Green Valley agrees to provide access and use of range facilities located at 4350 Academy Road, Hallsville, Missouri and 4900 N Wyatt Lane, Columbia, Missouri to the Columbia Police Department for official scheduled training.

This agreement with Green Valley would provide Columbia Police a facility to use for Range Qualifications Training, Firearms Training, and SWAT Training.

The agreement period is October 1, 2025 through September 30, 2026.

Fiscal Impact

Short-Term Impact: There is no additional fiscal impact with approving this agreement; the not-to-exceed amount of \$20,000 is available within the FY2026 Police operating budget. Long-Term Impact: 12 month agreement, no anticipated cost for years beyond two.
