Re: Missouri Arts Council Agreement – Heritage Festival and Craft Show

Executive Summary

The Parks and Recreation Department is requesting an ordinance authorizing the City Manager to sign a grant agreement, totaling \$14,938, with the Missouri Arts Council (MAC) and appropriate \$7,938 in funds. This allocation will be combined with \$7,000 in grant funding that was previously included in the FY2024 budget. The grant funding helps offset the expenses associated with the Annual Heritage Festival and Craft Show held at Nifong Park.

Discussion

The Parks and Recreation Department has hosted the Annual Heritage Festival and Craft Show for the past 45 years at Frank G. Nifong Memorial Park, located at 2900 E. Nifong Boulevard. This event is provided to the public free of charge largely due to efforts by parks and recreation staff to secure sponsorships and grant funding.

The Parks and Recreation Department received notification of a grant award, in the amount of \$14,938, from the Missouri Arts Council to help offset expenses associated with the annual event. The Department is requesting Council approval to execute the grant agreement with the Missouri Arts Council and appropriate the funding. The funding provides financial support for the artists and music performers.
