Re: Parks and Recreation Capital Improvement Project Appropriation Request

#### **Executive Summary**

The Parks and Recreation Department is requesting City Council approval to appropriate funds in the total amount of \$315,000 from the Park Sales Tax fund balance and Recreation Center Improvement Fund (RCIF) to capital improvement project accounts. The appropriation of funds includes \$40,000 from the Recreation Center Improvement Fund to the Activity & Recreation Center (ARC) capital improvement project to complete the replacement of the concrete front entryway at the ARC. The remaining funds, totaling \$275,000 in donated funds, will be used to complete the Cosmo Bike Park capital improvement project. All funds will be used to offset labor, materials and supplies for the two capital improvement projects as vetted through the City's CIP process. The discussion section includes details related to how the funds will be spent for each project.

#### Discussion

The Parks and Recreation Department is nearing completion of two capital improvement projects and an appropriation of funds is needed for each project to complete additional work associated with the projects.

#### **Activity & Recreation Center Capital Improvement Project:**

City Council approved a capital improvement project at the Activity & Recreation Center (ARC) on Jan. 17, 2023. The anticipated completion date of the entire project scope is Sept. 2, 2024. The foundation stabilization project included excavation of a portion of the concrete front entry to the ARC and staff is proceeding with the replacement of the entire entryway at this time. The existing entry walkway is 22 years old. Staff is requesting an appropriation of funds, totaling \$40,000, from the Recreation Center Improvement Fund (RCIF) to pay for the project. The replacement of the entry walkway will improve ADA accessibility and the aesthetics of the front of the facility.

### Cosmo Bike Park Capital Improvement Project:

City Council approved the Cosmo Bike Park capital improvement project on Jan. 17, 2023. The anticipated completion date of the entire project scope is Oct. 1, 2024. In order to complete all facets of the project, the Frank W. Morris Memorial Trust has donated an additional \$275,000 for the development of the bike park. Staff is requesting to appropriate funds in this total amount from the Park Sales Tax fund balance. The additional funds will allow the department to complete work at the park related to the installation of cyclocross features, starting and finish line structures for the race venue, additional electric needed on site, boulder placement, lighting installation and riding feature installation.

Staff will return to Council at a later date with an amendment to the original agreement with the Frank W. Morris Memorial Trust to outline the additional work related to the project scope and donation.

### Fiscal Impact

Short-Term Impact: The appropriations, totaling \$315,000, will be used to reimburse the two capital improvement project accounts for their corresponding expenditures. Staff does not anticipate an adverse fiscal impact associated with the appropriations, and all funds will be spent for their intended use.
